Dear readers

I am delighted to welcome you to the first issue of the WCS Mozambique Newsletter, whose main objective is to make known the activities carried out and, in particular, the success stories in the conservation of biodiversity.

WCS has been represented in Mozambique since 2012. During the first 7 years its focus was on technical and financial support from the Niassa Special Reserve (NSR), under the management of the National Administration of Conservation Areas (ANAC). Over the years, at the request of the Government, new programs have been incorporated, namely the Marine Program and the Contribution to Combat International Trafficking in Wildlife (CWT), through a specialized unit.

Throughout these years WCS, in the Niassa Special Reserve, established a management unit, built infrastructure for management and inspection, improved technical and tactical inspection systems, developed diverse community programs with emphasis on the production of honey and above all established cordial working relations with local authorities.

The year 2021 opens a new cycle for WCS Mozambique for the following reasons:

- WCS and the Mozambique Government have agreed, under the terms to be considered, the Co-Management Agreement for the Niassa Special Reserve, which should be signed in this half of the year; and
- In March, WCS International appointed Afonso Madope to the
 position of General Manager of WCS Mozambique, becoming the
 first Mozambican to head WCS Mozambique. In this position,
 Madope replaces Dr. James Bampton, who was a promoter and
 facilitator of the relationship with ANAC and in the last 5 years
 has ensured the necessary assistance to NSR.

This is the first edition, and the next ones are in press. Their success will depends on contributions and feedback from our esteemed readers. Best wishes to you all!

LAW ENFORCEMENT

- Comprising anti-poaching, combating illegal mining, reducing illegal logging & dealing with wild animals entering farms
- 11 crime reports and 21 NSR arrests for illegal mining and poaching in this quarter (13 Mozambican, 8 Tanzanian)
- High incidence of illegal mining in this quarter- typical of the rainy season
- High number of Tanzanian offenders highlighting the need to intensify actions at the border.
- 12 Honlg motorcycles acquired to help cover the reserve mainly in the rainy season, when roads become almost impassable - with support from the French Agency for Development (AFD).



HUMAN WILDLIFE CONFLICT

Fences installed for Mussoma & Macalange communities to protect maize and sesame from elephants, buffaloes and other antelopes. Benefiting 104 farmers, covering 30 hectares


- Development of a gap analysis and proposal of ToR for the establishment of an official Biodiversity portal for Mozambique based on the Clearing House Mechanism of the CBD

ADVANCING SHARK AND RAY CONSERVATION IN MOZAMBIQUE

- Meeting with the National Institute for Fisheries Research (IIP) to present the WCS Marine Program activity plan for the year 2021
- Preparation, production and dissemination of the posters of protected species of the new Maritime Fisheries Regulation in coordination with the National Fisheries Administration, IIP and World Wide Fund for Nature (WWF)
- Preparation of the sampling of sharks and rays in smallscale fishing and socio-economic surveys in coordination with the IIP, WWF and UniLúrio
- Participation in the 5th Annual Meeting of the Civil Society Forum for the Marine and Coastal Area FOSCAMC: presentations on the contributions to REPMAR and on the process of identifying Key Marine and Coastal Biodiversity Areas (KBAs).







PARTNERSHIP AGAINST POACHING AND ILLEGAL WILDLIFE TRADE (IN AFRICA AND ASIA)

- In the Southern region of Mozambique, 46 raids/incursions were carried out, resulting in 4 seizures
- In the Northern region, two (2) smuggling networks of wild products have been identified
- A trafficking network of 80 turtles/tortoises was dismantled with the logistics base on the Island of Mozambique
- Training on Open Source Intelligence (OSINT) conducted for 10 attendees representing ANAC, WCS National Parks (Limpopo and Gorongosa).
